eIDAS (electronic IDentification, Authentication and trust Services) is an EU regulation for electronic transactions in the European Single Market. Sectigo provides a range of products under the eIDAS regulation including certificates and timestamps. Certificates can be used to generate signatures and seals that ensure the legality of electronic transfers between citizens, businesses and government authorities across European Union markets. eIDAS certificates provide trusted assurance of authentication for electronically transmitted documents by validating author and document.

These certificates enable individuals and organizations (depending on the type purchased) to electronically sign or seal PDF and other documents in compliance with the eIDAS regulation. The certificate verifies the signatory's identity and authenticity of the document. The eIDAS regulation provides a recognized standard and chain of trust. It is primarily used within the European Union.

Qualified eIDAS signatures provide a higher degree of assurance and can hold the same legal effect as a handwritten signature. It requires a qualified certificate stored on a qualified signature creation device and must be issued and managed by a Qualified Trust Service Provider.

Qualified certificates from Sectigo enable individuals and organizations to sign or seal documents and meet eIDAS requirements.

**PSD2 Certificates**

PSD2 is a regulatory framework to ensure that payments across the EU are secure, easy, and efficient. PSD2-compliant certificates can only be issued to legal persons that have a PSD2 authorization number as issued by a National Competent Authority (NCA).
